KQXL'S "MARDI GRAS PRIZE PACK" CONTEST OFFICIAL RULES

The Station will conduct the **KQXL's "MARDI GRAS PRIZE PACK"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. The Contest is subject to all applicable federal, state and local laws and regulations. - 2. **Contest Period.** The Contest will begin at **10:00am CT on Wednesday, January 13, 2021** and will run through **9:59pm CT on Friday, February 12, 2021** (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- 3. **How to Enter.** To enter, each entrant must:

 - (d) Complete an entry form

All entries must be received by 9:59am CT Friday, February 12, 2021 to be eligible for a chance to win a prize. Multiple participants are not permitted to share the same telephone number. Any attempt by any participant to submit more than one (1) entry by using multiple/different telephone phone numbers, identities, or any other methods will void that participant from further participation in the Sweepstakes.

Limit one (1) entry per person.

Multiple entrants are not permitted to share the same telephone number or email address. Any attempt by any entrant to submit more than one (1) entry per by using multiple/different email addresses, telephone numbers, identities, registrations and logins, or any other methods will void that entry and the entrant may be disqualified. or misdirected entries, all of which will be disqualified. The "authorized account holder" is the natural person assigned the telephone number by the wireless carrier or an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Potential winner may be required to show proof of being the authorized account holder. All entries become the sole and exclusive property of Station and will not be returned. Station reserves the right to contact entrants and all other individuals whose email address is submitted as part of this promotion. No mail-in entries will be accepted.

- 4. **Winner Selection.** There will be twenty (20) Contest winners, as follows: At or about 10am and 3pm CT on each weekday, January 18 February 12, the Station will select two (2) potential winners in a random drawing from among all valid entries received by Station during the Contest Period. The winning entrants will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification will result in disqualification and forfeiture of the prize. **LIMIT ONE PRIZE PER PERSON.**
- Verification of Potential Winners. THE ELIGIBILITY OF ALL POTENTIAL CONTEST 5. Each potential winner may be notified by email and/or telephone call after the date of random drawing and/or winner determination. Each potential winner will be required to sign and return to Station, within three (3) days of the date notice is sent, an affidavit of eligibility and a liability/publicity release (except where prohibited) in order to claim his/her prize, if applicable. A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to rescind such winner's acceptance of the prize and/or return the prize. Station's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.
